AUCTION PROCEDURE FOR FIRST TIME BUYERS

REGISTRATION

- Registration fee is R100 refundable
- Registration only on the morning of the auction from 08h30.
- FICA Documents INDIVIDUALS – ID, Proof of residence, Proof of bank details
- FICA Documents COMPANIES – Company Reg Docs, ID's of all directors, Proxy letter from company, ID for Proxy, Proof of business address, SARS registration certificate

BIDDING

You are to bid only on a property that you have seen and that you are sure of:

PAYMENTS AND LIABILITIES

All prices are VAT Exclusive: If the bid is given at a R100 you will have to pay R115.

No syndicated bidding or collusion will be allowed, any bidders found guilty of this may be banned from future auctions.

Only registered bidders may purchase a property and all risk falls on the purchaser the moment the bid is awarded.

Goods are sold voetstoots with no guarantees.

Vehicles sold at auction are sold voetstoots with no guarantee. Registration of vehicles purchased at auction with the Traffic Department is the responsibility of the purchaser, the Sheriff will assist with all relevant documentation as may be available to assist with registration but can give no guarantee.

Payments to be made in cash or eft IMMEDIATELY AFTER THE AUCTION with the accountant. Only bidders with a stamped invoice and receipt will be allowed to remove goods from the store room.

Failure to make payment on the day of the auction will result in the goods being put up for auction again, forfeiture of your deposit and not being able to register or bid for any subsequent auctions.

Goods have to be removed before 15h00 on the day of the auction, any items not removed will be sold at the next auction to recover costs.
